Mr. Taylor called the meeting to order at 7:30 P.M. There were 8 people and a Mercury Reporter present in the audience.

## PUBLIC COMMENTS:

<u>ALLYSON ELLIOTT</u> - Assistant Township Manager from Lower Pottsgrove Township was present to discuss the proposed Pottstown Metro Area Compost and Recycling Facility which is planned for the corner of North Charlotte Street and Bliem Road in Lower Pottsgrove Township.

**<u>ROD HAWTHORNE</u>** - Township Manager from Lower Pottsgrove Township stated he would be willing to meet with the members of the Board and/or Staff to discuss the proposed facility.

**<u>REG LEISTER</u>** - <u>1693 Farmington Avenue</u> - Requested an update regarding the hiring of the new Police Chief. Commissioner Taylor stated the Board is currently in discussion with a couple of candidates and hopes to make an offer shortly.

**PAYMENT OF BILLS CONT'D** - A motion by DeLena, seconded by Spaide, to approve the Bill List dated September 2, 2008, for General Fund in the amount of \$14,367.68; for Sewer Fund in the amount of \$2,675.66, for Open Space Fund in the amount of \$3,600.00; for State Fund in the amount of \$1,743.59 and for Capital Fund in the amount of \$115,144.75. Total Expenditures - \$137,531.68. All aye votes.
