This may have been at the request of Twp Mgr Layne or Board President Taylor. All agreed that services charged to or incurred on behalf of Civil Service should be otherwise be approved by Civil Service. Cmsr Leister pointed out that in the past there were cases where Atty Ryan Cassidy, who is the Twp's labor atty had been charged to Civil Service in error.

This will have to be addressed as a priority in 2008 in case anyone requests a copy of same, especially with the newest changes involving the Promotions approved in August.

Discussion: We will approach the Twp to assist in completing the collation process including the revised Application. This must be addressed ASAP.
