



Township Police Alert Residents to New Traffic Regulations that Become Effective this Month (January 2007)

First, new motor vehicle regulation requires motorists to turn on their headlights anytime their vehicle windshield wipers are in continuous or intermittent use due to weather or other atmospheric conditions such as fog or mist. Motorists that fail to comply with this law could face a fine of \$25.00, but with additional fees and costs imposed, the traffic citation will cost in excess of \$100.00.

Motorists must remove snow and ice from vehicles before traveling. This new regulation will impose severe fines if ice or snow should fall from their vehicle causing injury or death to other motorists or pedestrians. Drivers in violation of this section are subject to a fine of \$200.00 to \$1,000.00 for each offense.

Lastly, drivers will be required to move to the outside lane when they approach a stopped emergency vehicle including police, fire trucks or tow trucks. It is reported that the law will also cover highway workers and others who deal with roadside emergencies. The department has not yet been informed of the effective start date for this proposed regulation. Please look for additional press releases for additional information on this regulation.

Booster Seats

Upper Pottsgrove Township Police Department has purchased child open-end booster seats as part of our ongoing Community Service Program

These seats are available at a cost of \$10.00 each.

This department also has a free program available to parents to instruct them in the installation and purchase of child safety seats. This service is available by contacting Child Safety Seat Specialist Officer Jason Zoski at 610-326-8446 for an appointment.


2006 was a busy year for the Pottstown Public Library. Library use was up in all areas with 2,637 new borrowers registered, 21,321 computer use sessions, and 118,482 items checked out. Upper Pottsgrove residents borrowed 5,370 items from the library. There were 6,186 people who attended the 298 programs offered throughout the year for children, teens, and adults.

It's not too late to sign up for one of four weekly Story Time programs!

- Open Stories on Mondays at 10:30, all ages
- Snacktime Stories on Tuesdays at 4:00, all ages
- Infant Stories on Thursdays at 10:30, ages 8 mo. to 2 yrs.
- StoryJam with Mr. Mike and his guitar on Thursdays at 2:00, ages 3-6

March is Family Reading Month. Children who read 20 minutes a day for 20 days with a family member will earn a prize. Register in the library to receive a reading calendar and cool stuff.

Ongoing adult programs include two monthly book discussion groups: the Reading Club on the next to last Tuesday evening at 6:00 and Mystery Readers on the third Tuesday morning at 10:00 each month. Tai Chi sessions, sponsored by a grant from the Pottstown Area Health & Wellness Foundation, have been a popular program on Monday and Tuesday evenings. Storm Water Management—Commitment to Education (Continued)

*Why is storm water runoff
a problem?*

Storm water can pick up debris, chemicals, dirt and other pollutants and flow into the storm sewer system or directly to the stream, wetlands or creeks.

Anything that enters a storm sewer system is discharged untreated into the water bodies we use for swimming, fishing and providing drinking water.



The effects of pollution


- Polluted storm water run off can have adverse effects on plant life, fish, animals and people.
- Sediment can cloud the water and make it difficult for aquatic plants to grow.
- Excess nutrients can cause algae blooms. When algae die, they sink to the bottom and decompose in a process that removes oxygen from the water. Fish and other aquatic life cannot exist with low dissolved oxygen levels.
- Household products like insecticides, pesticides, paint, solvents, used motor oil and other automotive fluids can pollute drinking water. This, in turn, can affect human health and increase drinking water treatment costs.



Clearing Snow from Driveways

The winter season is fast approaching and it is time to start thinking about snow removal in Upper Pottsgrove Township. Every winter season, the Township receives calls from homeowners who have had their driveways "plowed in" with snow during the Township's snow removal activities. In order to help make the snow clearing process more enjoyable for residents and the Township employees who operate the plows, listed on page 6 is a suggestion to help keep driveways clear after the plows have passed.





HOW TO CLEAR YOUR DRIVEWAY OF SNOW



**INSTRUCTIONS FOR
HELPING TO KEEP
YOUR
DRIVEWAY CLEAR
OF SNOW AFTER
THE
TOWNSHIP PLOWS
HAVE PASSED**

- 1) Facing the street, clear an area to the left of your driveway.
- 2) As a result, all of the snow that you clear should be placed to the right of your driveway.
- 3) This cleared area will help "catch" displaced snow that would otherwise land in your driveway.
- 4) Please, note that clearing the snow to the left of your driveway will not keep all of the snow out of your driveway, but it will greatly reduce the amount that you will have to "re-shovel."
